



### Payments

To ensure the reservation of Thembela bookings, kindly note that completion requires the signing and submission of the contract to the venue administration, accompanied by the full deposit.

For all Electronic Funds Transfer (EFT) payments, please provide proof of payment.

Thembela retains the right to cancel the wedding in the event that any outstanding amounts are not settled promptly. Your cooperation in this matter is greatly appreciated.

To secure your date, a 30% deposit of the total value is required and is non-refundable in the event of wedding cancellation.

Three months prior to the wedding, a payment of 70% of the total amount is due and is also non-refundable if the wedding is cancelled.

The final outstanding amount is due two months before the wedding and, similar to the previous payments, is non-refundable in the event of wedding cancellation.



### Legal Matters

Please be advised that utilization of THEMBELA venue is undertaken at your own risk.

The staff at Thembela venue explicitly disclaims responsibility for the loss of personal belongings and/or injuries.

Reservation of the right of admission is strictly observed.

While THEMBELA venue maintains a non-smoking policy indoors, designated outdoor areas are provided for smoking.

The bridal party is entirely accountable for the safekeeping of presents, including envelopes containing cash. THEMBELA venue's staff shall not be held liable for the safeguarding of wedding gifts.
